Helping achieve affordable warmth

The ScottishPower Energy People Trust continues to have a tremendous impact across Britain, working with charities to help vulnerable and fuel poor households.

Since the Trust's launch in 2005, almost one and a half million vulnerable people suffering from fuel poverty have been supported through a range of measures offered by local charities and funded by the Trust.

During 2011, £1,357,720 was given to 52 existing projects and to 26 new projects that will help people with affordable warmth.

By the end of 2011, a total of £9.1 million had been awarded to 188 projects helping 1.27 million households in Britain.

The Trust is an independent charity established to help end fuel poverty in Britain and is administered by, but makes decisions independently of, ScottishPower. Decisions are made by an experienced Board of Trustees who have a special interest in fuel poverty.

They include representatives from Energy Action Scotland and National Energy Action.

The Trust was established in November 2005 and meets on a quarterly basis to consider applications from registered charities that represent fuel poor households. It exists to provide much needed funding to these organisations for projects which combat fuel poverty through investment in three categories – crisis funding, income maximisation and energy efficiency.

In many cases funding is awarded to projects spanning two or all three of these categories.

Fuel poverty is when 10% or more of household income is spent on energy costs and the Trust is aiming to achieve affordable warmth for all. The problem arises when people on low incomes live in poor housing, which is difficult to heat and keep warm. National Energy Action estimated that around seven million households in the UK are fuel poor.

The Trust's three categories of funding

Crisis funding – support to organisations who help young people setting up their first home and families on low income.

Income maximisation – providing funding to front line charities that provide benefits advice to households missing out on financial help that they are entitled to through welfare benefits and tax credits.

Energy efficiency – improving home energy efficiency through draught proofing, insulating and offering energy efficiency advice.

(or a combination of the above.)

Chairman's message

Looking back on 2011

I'd like to open this year's annual review message by saying a big thank you to retiring chairman Hammy Smillie for his tireless hard work and enthusiasm over the last five years.

My main aim when I was elected chairman of the Trust was to keep it moving along the path of supporting groups whose work particularly focuses on families and children and I am confident that we have achieved that this year.

During 2011 the Trust made 78 funding awards of between £400 and £55,000. The funding was given to organisations implementing projects and schemes to assist households suffering from fuel poverty, which is when a household has to spend more than 10% of its income on all household fuel costs. This funding is helping grassroots organisations tackle the issues surrounding fuel poverty and importantly affordable warmth.

The Government introduced the Warm Home Discount scheme on 1st April 2011. It is a four year initiative to help low-income and vulnerable households with energy costs and offers a programme of support aimed at customers who are living in, or at risk of, fuel poverty. I'm delighted to say that The ScottishPower Energy People Trust is an Ofgem approved industry initiative within this scheme and this means we can continue to help fuel poor families across Great Britain.

In September 2011, the Trust held a seminar event in Glasgow City Chambers

supported by nine of the projects which had benefitted from Trust funding. Delegates were welcomed by Baillie Liz Cameron from Glasgow City Council with various projects presenting case studies and discussing best practice.

The event was attended by a range of key stakeholders including Ofgem, Glasgow City Council, The Wise Group, Maryhill Housing Association, Grand Central Savings, Friends of the Earth Scotland, Milnbank Housing Association, Scottish Government, Scottish Federation of Housing Associations and Citizens Advice Scotland. It was very worthwhile and an extremely useful platform for sharing ideas and best practice in relation to affordable warmth. During 2011 we also said farewell to two further Trustees – Liz Futcher and Helen Walker. We would like to thank them for their work and commitment to help alleviate fuel poverty. Over the next twelve months we will welcome two new Trustees in their place who have an interest in and knowledge of fuel poverty and how it impacts on individuals.

Looking forward to 2012, the Trust will continue in its crucial role working with charitable bodies to ensure that together we continue the fight against fuel poverty with the long term shared goal of eradicating it altogether.

Company Secretary's report

Making a difference and tackling fuel poverty head on

We have increased the amount of funding available in 2011 and we continue to raise awareness and encourage applications from organisations across the country which can provide a wide range of support, including crisis funding; energy efficiency funding, and income maximisation advice. The annual report highlights just a few of the many successful projects we have funded over the last twelve months.

The ScottishPower Energy People Trust has by the end of 2011 donated £9.1 million to not-for-profit organisations that work with, or represent, the vulnerable and fuel poor to help those most in need.

Since the Trust was launched in 2005 as an independent charity established to help end fuel poverty in Britain, more than 1.4 million vulnerable people who have found themselves in financial difficulty and are spending more the 10% of their income on household fuel costs have been supported effectively with our help.

By establishing a network of 'on the ground' projects across the length and breadth of Britain, the Trust is able to direct funds to those who are most in need. By tapping into the extensive knowledge each individual project has of the area in which it operates, we have been able to make a significant difference to the lives of many families.

During 2011, £1.3 million in total was given to 52 existing projects and to an additional 26 new projects. The projects funded in 2011 alone will help 31,089 fuel poor in 16,883 households across Britain.

As ever, we have been amazed by the results that have been achieved by our partner agencies who must be congratulated for the valuable expertise and experience they bring in tackling the complex issues associated with fuel poverty head on.

This year saw the Trust host its inaugural 'Best Practice' event which saw projects from across Britain come together for the first time in the Trust's history to share their experiences and expertise and learn from one another.

My thanks must go to Baillie Liz Cameron of Glasgow City Council for kindly agreeing to host the event on our behalf and to the many representatives of the organisations who travelled from all corners of country to be there.

I am extremely proud of the significant progress that has been made in the last year in our bid to tackle fuel poverty and I look forward to working in partnership with you in the year ahead.

Coming together to create affordable warmth

On September 6, 2011, the ScottishPower Energy People Trust held a seminar event in Glasgow City Chambers to allow the Trust and projects from across Britain to share some of the best practice in alleviating fuel poverty.

Representatives from nine funded projects met Trust stakeholders and listened to a variety of presentations.

By the end of 2011 more than £9 million of funding had been donated by the Trust and the event highlighted its excellent work and the tremendous successes of funded projects.

Baillie Liz Cameron of Glasgow City Council introduced the event, followed by Chairman of the Trust, Norman Kerr, discussing the role of the Trust and its future objectives.

Presentations followed from Bill Brown from Development & Regeneration Services for Glasgow City Council and Graeme Mullin from G. Heat who discussed the benefits of partnership working whilst delivering the G.HEAT project.

G.HEAT provides face to face advice to vulnerable residents in fuel poverty in terms of energy billing, including obtaining the best tariffs and benefits health check. This advice includes taking the householder through the application process, including

making online applications, and providing advice on the best use of energy in the home.

Denise Howell, from National Energy Action spoke about the excellent work the 'Warmer Healthier Children' project was undertaking. It is run in partnership with Energy Action Scotland and delivers training sessions to a wide range of agencies working with children between the ages of 0-16 and from different family groups. Its aim is to ensure professionals working with vulnerable families are able to communicate energy efficiency issues effectively, and to raise awareness and understanding of the impact of poor housing conditions on the health of children and young people.

Jackie Hankins and Rebecca Shepherd from Neath Port Talbot Welfare Rights Unit highlighted the achievements if their 'Fuelling Kids' project. The project provides comprehensive welfare benefits advice within some of the poorest regions in Wales. The project targets families most at risk of fuel and income poverty, providing them with benefit health checks, debt and energy efficiency advice. Clients are contacted through partnership working with other organisations, running and attending events and through surgeries in schools.

Norman Kerr, Chairman of the ScottishPower Energy People Trust, summed up the event: "I would dearly love to be in a position where I came and said to you that the Trust was no longer needed simply because we had achieved a state of affordable warmth. I think unfortunately ladies and gentlemen that is going to be sometime in the future but until that time the Trust will continue to do good work and I hope that you will all at some point be able to take part in that."

Brighton and Hove based Amaze provides support to parents of children with special needs and disabilities. The charity was awarded £90,000 by the ScottishPower Energy People Trust to tackle fuel poverty and has since helped families to secure £6 million of additional benefits they were entitled to claim.

Amaze ran a three year project with one full time member of staff supported by 10 volunteers which provided an holistic approach to alleviating fuel poverty. With a focus on income and energy efficiency, team members were trained in benefits checks, energy efficiency advice and savings advice.

A total of 737 families were assisted with disability living allowance claims over the duration of the project which resulted in generating an extra £6million for those helped.

Ann Loughrey, Head of Corporate Social Responsibility at ScottishPower and The ScottishPower Energy People Trust Company Secretary, said: "It is a fantastic achievement for an organisation to be given £90,000 and turn that into a £6million benefit for people requiring assistance in the local area. Amaze has effectively turned

every £1 the Trust donated to them into a benefit of £66 for disadvantaged families.

"These exceptional increases in family household budgets, as a result of Amaze advice services, have helped relieve the stresses of fuel poverty and contribute to a better standard of living for the participating families."

Lizzie Batten, project co-ordinator at Amaze, said: "We would like to thank ScottishPower Energy People Trust for its support and funding. It has enabled us to reach families with disabled children to help them find extra income from unclaimed benefits and help lift them out of fuel poverty.

"Many families were unaware of the extra assistance that was available to them. The funding has allowed us to visit them and spend time to help them with their disability living allowance claims and will continue to make a difference to local families for many years to come."

DAVID'S STORY

David Page and his family are just one of the hundreds who have been helped out greatly by AMAZE.

AMAZE helped David with financial advice after his partner was diagnosed with Lupus, an incurable debilitating immune system illness, and his son Niels was diagnosed with a severe form of epilepsy.

Staff at AMAZE helped David to appeal the lowest rate of Disability Living Allowance and succeeded in raising it to help the

family cope with their son's condition.

David was also helped by the support worker who was funded by the ScottishPower Energy People Trust. The case worker assisted with a housing application for a new home with an additional bedroom for a carer who could stay with Niels and help him during the night.

David said: "We can't thank the ScottishPower Energy People Trust enough for helping to fund AMAZE – I don't know what we would do without their support. Unless you are aware of the rules and regulations, there is a real chance you may miss out on benefits you are entitled to.

"I don't think we would have managed to survive as a family if we didn't have the help and support. We didn't know how to access the help and support we were entitled to and AMAZE has enabled us to get on with our lives."

"Failing to address fuel management can lead to debt problems and inability to manage the home. We are working to improve understanding of fuel issues so many more people will have increased disposable income and thus more to spend in local shops and businesses which will in turn provide a boost to the local economy."

Warm Zone project proves a great success

North Staffordshire Warm Zone's 'Access to Benefits and Claim Support' project was provided with funding from the Trust to help families at risk of fuel poverty to claim £655,000 in additional benefits they were entitled to.

A total of £41,354 was granted by the Trust which has helped over 1,595 families since the initiative began in 2008.

Twenty outreach sessions were carried out which involved a drop in service, tailored individual interviews, and awareness sessions with parent groups to provide advice on energy savings and benefit checks.

Ann Loughrey, Head of Corporate Social Responsibility at ScottishPower and the ScottishPower Energy People Trust Company Secretary, said: "We are very pleased that the residents of North Staffordshire have been able to access a total of £655,000 in unclaimed benefits. It is clear that the £41,354 donation to North Staffordshire Warm Zone has been

able to make a real difference to the lives of families in the area."

Sophie Thorley, Director at North Staffordshire Warm Zone, said: "The funding has enabled us to reach local residents to help them find extra income from unclaimed benefits and help lift them out of fuel poverty. "Many individuals were unaware of the help that was available to them. The funding has allowed the project to provide information and services to North Staffordshire residents in a straightforward and personal way and will continue to make a difference to local people for many years to come."

Dumfries and Galloway residents secure more than £2.5m in additional benefits

Dumfries Welfare Rights has helped more than 6,500 people in the area claim in excess of £2.5 million of available benefits.

The ScottishPower Energy People Trust provided funding of £99,888 over two years to assist parents with young children who were struggling with fuel poverty across the region.

The organisation's Fuel Poverty Income Maximisation for Families with Young Children project used the funds to employ two full-time workers to help families who were struggling with low incomes. The project enabled them to claim benefits they were entitled to and ensured they had access to comprehensive energy efficiency advice.

William McCormack, Manager of Dumfries Welfare Rights, said: "Over the last two years, more than 6,500 families in the area became more aware of the benefits that they are entitled to, and we have shown them how they can reduce their fuel bills substantially through the support of our energy advisors.

"The funding from the ScottishPower Energy People Trust has enabled our organisation to tackle the ongoing struggle that less well off families can face each year with fuel poverty and we are very grateful for the donation we received."

£70k turns into £750,000 for Neath Port Talbot residents

A Neath Port Talbot project which helps families most at risk of income and fuel poverty is proving of great benefit to the local community.

The 'Fuelling Kids' project was provided with £72,930 of funding by the ScottishPower Energy People Trust to help families with benefit health checks, debt and energy efficiency advice. Over 3000 people have been contacted since the initiative began in 2009 enabling them to access £750,000 in unclaimed benefits.

Funding was used to employ a project worker to help people requiring support. Clients are contacted through partnership working with organisations such as schools and by running and attending events including advice surgeries.

As a result of accessing the advice service, many clients will have and increased income and thus more to spend in local shops and businesses therefore providing a boost to the local economy.

Ann Loughrey, ScottishPower's Head of

"We're delighted that the funding provided has made such an immense difference to people in Neath Port Talbot. Ypeople secure funding to help those in fuel poverty

Ypeople, formerly YMCA Glasgow, was awarded £58,177 by the ScottishPower Energy People Trust to implement an energy saving initiative.

The registered charity used the funding to provide energy efficiency advice services to over 1200 people who are currently, or will be in the future, residing within its supported accommodation services across central Scotland.

By providing this advice and implementation of energy saving initiatives Ypeople aims to significantly reduce its energy bills, the impact on the environment and its carbon footprint.

Ann Loughrey, ScottishPower's Head of Corporate Social Responsibility and The ScottishPower Energy People Trust's Company Secretary, said:

"We are delighted to fund this new energy

saving initiative run by Ypeople. A large part of the project is about energy saving advice and education and we're positive that with the money provided Ypeople will be working to help alleviate fuel poverty for its clients. We wish the organisation well in providing valuable advice to service users to help them manage their electricity usage."

Projects funded during 2011



Ypeople

Glasgow-based charity Ypeople received funding for its Glasgow Energy Saving Initiative which aims to provide an energy efficiency advice service to people currently, or in the future, residing within supported accommodation across Central Scotland. Through advice and implementation of energy saving initiatives, Ypeople's support will significantly reduce energy bills and the impact on the environment and carbon footprint.



National Energy Action 2 Nauo.... £96,463

National Energy Action received funding to employ a full-time project officer to deliver its Home Energy Advice Team (HEAT) project in Coventry, delivering fuel debt advice via home energy visits. The project provides advice and support to vulnerable fuel poor households including the elderly, families with young children, disabled households and black and ethnic minority groups



Wealden Citizens Advice Bureau. £38.000

Wealden Citizens Advice Bureau received funding to recruit a Fuel Poverty Income Maximisation worker. The staff member will run benefit checks to maximise income, give debt advice for their utility debts, help clients apply for grants and special fuel tariffs as well as referring them to relevant organisations who can help with fuel efficiency measures.



Roundabout

Roundabout received funding for its Income Wellbeing Project which supports young people on low incomes and in most situations workless, often because of their homelessness. The Sheffield based project used the funding to employ and train a member of staff on energy efficiency and income maximisation. The project targets young people who have previously been homeless and living in secure accommodation and provides detailed advice on energy efficiency, fuel poverty and keeping warm.



Carers of East Lothian

Carers of East Lothian, based in Musselburgh, aims to support adult carers to maximise their income and achieve a sustainable reduction in fuel poverty through its Warmer and Better Off project. It received funding to employ a fuel poverty worker to offer advice on energy efficiency, support a better understanding of bills and tariffs, and run training courses on income maximisation checks and advise on availability of energy efficiency grants and care package options.



Dundee Carers Centre

The Dundee Carers Centre received funding for its Caring In Crisis project which undertakes benefit checks and income maximisation work. The project will work in partnership with the Dundee Energy Advice Project and accept referrals that have been identified as requiring more specialist advice on energy efficiency. The project will deliver Financial Capability training to carers and young carers. This training will also enable the project to be pro-active and reduce the number of people reaching crisis point.



Bristol Debt Advice Centre

The Energy Advice Project (EAP) run by Bristol Debt Advice Centre, received funding to expand in the following areas: crisis grants for household items; stay and play advice sessions at children's and family centres; one-to-one energy efficiency and debt advice; and frontline worker training. The project offers a range of free services to clients to help them avoid and address fuel poverty and fuel debt.



DHA £26.233

The Warming Erewash project based in Derby, received funding to provide one-toone support and advice to enable families to move out of fuel poverty and live in warmer homes. DHA (formerly Derbyshire Housing Aid) will use its extensive knowledge of the local community and the issues faced by vulnerable people and families to deliver face-to-face sessions, combining energy efficiency advice and information with money and debt advice and practical guidance on maximising income via welfare benefits and reducing monthly outgoings.



South Hams Citizens **Advice Bureau**. £32.716

The Bureau aims to undertake benefit entitlement checks to clients identified as at risk of being in fuel poverty; who are experiencing debt problems due to low incomes and high costs of fuel bills. The organisation received funding for its Tackling Cold Homes project which aims to support clients and help them understand and act upon energy efficiency advice and identify customers eligible for social tariffs.

Projects funded during 2011



Youth Action Ltd, Blackburn £95,000

The Youth Action Ltd project aims to engage and empower young vulnerable people to tackle fuel poverty, through ground level research with families and peers. The funding received will cover the cost of employing a part-time fuel advisor who will be able to advise on grants available, sources of advice and ways of saving energy and reducing fuel poverty.



Claverhouse Training

£57,877.50

Claverhouse Energy Flat, a project run by Claverhouse Training based in Dundee, received funding to extend the use of a facility and employ a project worker to continue assisting large numbers of longterm unemployed people in fuel poverty. The project will run regular sessions for small groups of clients incorporating advice, signposting for support and practical demonstrations of energy saving techniques.



Fraserburgh Families

The Children 1st project, Fraserburgh Families, received funding to support families where parents are recovering from drug misuse. The team will undertake direct interventions with the families who are in financial crisis. supporting them to access benefits, manage their finances better and maximise their incomes. The interventions involve an assessment of the difficulties the families are experiencing, the development of an action plan and arranging appointments with benefit agencies.



Brighton Unemployed Centre Families Project, £15,000

The Brighton Unemployed Centre Families Project received funding to extend its service to include greater provision for addressing the issue of fuel poverty. The Fuel Poverty Action project will offer explicit advice and targeted sessions addressing issues of fuel poverty for centre users, many of whom are people struggling to pay energy bills.

Ormiston Children and Families Trust (OCFT), £79,993

The primary objective of the Keeping Families Warm project is to reduce the levels of fuel poverty experienced by the vulnerable children and families that Ormiston Children & Families Trust work with in Norfolk. The funding will enable OCFT to work alongside vulnerable children and families to maximise their income and ensure their homes are warm and healthy.



Independent Living Support £60.000

The Independent Living Support (ILS) project based in Dumfries received funding for its Empowering People Plus (EPP) project, which provides support to help people negotiate and agree sustainable energy payment arrangements, and where necessary, provide advocacy and conciliation services. ILS will carry out benefit health checks and enable individuals to maximise their income and support individuals to effectively manage their finances.



Harrow Citizens Advice Bureau £71.269

The Bureau received finding to run the Harrow Fuel Poverty Project which aims to provide a number of vital services to

those most vulnerable families living in fuel poverty. This includes income maximisation checks to ensure families are claiming benefits they are entitled to such as benefits and tax credits; advice on dealing with fuel debt and applications to the various energy company charitable trusts for help to clear fuel arrears; energy efficiency advice and a small emergency fund for food, fuel and emergency payments.



Quarriers 17 £29,182

Quarriers, based in Bridge of Weir, received funding to deliver the second phase of its HEAT project which will build on learning gained from two previously funded ScottishPower Energy People Trust projects. HEAT Phase 2 will provide a structured programme providing practical skills, knowledge and advice on how implementing energy saving strategies can help with budgeting and provide start up packs to help relieve the financial pressure of 100 young homeless people, currently supported by Quarriers housing support services, move into their first home.

The funding will enable OCFT to work alongside vulnerable children and families to maximise their income and ensure their homes are warm and healthy. Ormiston Children and Families Trust (OCFT)



Speakup Self Advocacy Ltd

£42,306

Speakup Self Advocacy Ltd based in Rotherham, received funding to run its I'm An Expert Energy Saver project which has trained Energy Efficiency Champions to help vulnerable, disadvantaged and disabled people understand energy efficiencies. The main aim of the project is to support people with learning disabilities who are moving to live independently to be energy efficient. This involves providing them with advice about draught proofing, insulation and benefits checks should they struggle with energy bills.



Starter Packs Inverciyde

Starter Packs Inverclyde is a charity that provides essential basic items such as kitchen and bedding packs to homeless people who are moving into new tenancies. The project aims to relieve the financial pressure associated with taking up a new tenancy, allowing them to pay for heating, lighting and food costs which in turn helps to sustain their tenancy. The funding provided will pay for a number of essential items such as duvets within the starter packs as well as advice on energy efficiency.



Regenda Ltd

£5,340

The Regenda Ltd project received funding to launch its Neighbourhood Energy Challenge, which invited households in the Chester area to compete against their neighbours to make the largest reduction to their energy bills. Participating households will receive an energy efficiency make-over to their properties which will include extensive air tightness works, installation of smart meters/ energy monitors, fitting of radiator panels and intelligent energy-saving plugs. The team will also be providing benefits, welfare and energy-efficiency advice to the community.



Beat The Cold

£31.025

Beat The Cold received funding for its Warm Moorlands Homes project which provides expert, face-toface advice in the homes of vulnerable households within the Staffordshire Moorlands District. Fuel experts



check bills and meters, change tariffs and apply for Warm Home Discount as well as negotiate with fuel

companies, charitable trusts and other sources of support on behalf of vulnerable individuals.



ShARP received funding to employ a parttime energy adviser to support its clients by offering energy advice in addition to its current welfare rights service. The energy adviser will offer practical advice on energy efficiency and will also be employed to know which other organisations in the Sunderland area can also be of support. In addition to working with clients on an individual basis, drop-in sessions and coffee mornings provide people with access advice on energy.



Care & Repair Leeds £50,000

The Warm Homes Project will link to an existing project set up in partnership with NHS Leeds and Leeds City Council which aims to assist vulnerable households suffering from long-term illness and provide an easy referral route for community based workers to householders suffering from cold related illness with assistance to alleviate fuel poverty. The funding received for The Warm Homes Project will significantly widening the number of organisations that will be trained to refer people to relevant agencies



Credit Union for South East Northumberland, £49,022.40

CUSEN received funding to employ a 'Home Heat Helper' for its Home Heat Team to work across Northumberland to increase awareness of fuel poverty amongst some of the most vulnerable families. The aim of the Home Heat Team is to encourage people to access energy efficiency loans which are not currently being accessed due to a lack of awareness and to help them understand how they can help reduce their fuel bills.

Summary of our financial performance during 2011

Financial outturn for year

The charity's income for the period amounted to £705,475. The charity paid out £1,357,720 in grants and had a deficit of £691,187.

Unrestricted reserves at the period end were £1,858,254 of which £1,372,516 was held in a designated fund for future grants that have been approved.

Principal Funding Sources

During the financial period since inception, ScottishPower has contributed in excess of £9.1 million to the Trust. The Trust is committed to exploring additional funding routes as outlined in more detail below.

Investment Policy

Aside from retaining a prudent amount in reserves each period, most of the charity's funds are to be spent in the short term so there are few funds for long term investment.

The Trustees have noted their intention to review the banking arrangements on an ongoing basis, thereby ensuring maximum returns for the Trust as far as possible.

Trustees ask the Treasurer to consider the best banking option for trust funds in the current economic climate and this is kept under review and discussed at Trustee meetings.

Reserves Policy

The reserves are needed to meet the working capital requirements of the Trust and the Trustees remain confident that the current level of reserves is sufficient to allow the continued activity of the Trust through 2010.

The charity currently has a designated grants reserve of £1,372,516, to pay grants that have been approved and are to be paid in future years subject to conditions being met.

The charity currently has a general reserve of £485,738. The current surplus held by the Trust will continue to be awarded to worthwhile projects consistent with the Trust strategy. Similarly, discussions will continue with all parties in an effort to secure additional funding as the period develops.

Who can apply for funding from the Trust?

The ScottishPower Energy People Trust can provide funds for registered charities who work with or represent the vulnerable and fuel poor to help those most in need. These include, but are not limited to, children's charities, local community groups, support organisations, housing associations and local authorities.

What type of projects are eligible?

- Organisations which provide crisis funding, particularly for women and children needing emergency accommodation and vulnerable young people setting up their first home.
- Groups which provide households with benefit health checks or income maximisation are also encouraged to apply. As are those helping households that are not claiming all the benefits to which they are entitled; or are not eligible for current government funding because they do not receive the appropriate benefit.
- Any organisation which supplies energy efficiency measures and advice, through schemes which improve the energy efficiency of homes by draught proofing insulating and offering energy advice.

When are submitted projects reviewed?

The Trustees meet once a quarter to review submitted projects.
